Student Awards

1. PA Program Academic Achievement Award

Description

> To recognize the Academic Achievement of a graduating Physician Assistant student

Eligibility

> The Year 2 BScPA Student in good standing

Nomination & Selection Criteria

Determined by Program Director in August, annually, to a graduating student, with the highest cumulative grade point average (cGPA) in their cohort, upon program completion (15 credits)

Award Logistics

Graduate notified by email, official letter and award provided at Fall Convocation event

2. PA Student of the Year

Description

> To recognize a Year 2 PA student for demonstrating exemplary qualities of a Physician Assistant

Eligibility

- > Any Year 2 BScPA Student in good standing
- > Winners of another PA student Award, are not eligible for this award

Nomination

- Nominated by peers, self, faculty or PA/MD teachers
- Nomination is to include:
 - Full name of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:
- A summary of the known contributions supporting the nomination
 - The impact of these contributions on others

Selection Criteria

- > Judged by the Awards committee
- Criteria to include any of:
 - Collaborates with others
 - Provides service to advance the PA profession
 - Demonstrated leadership in local, regional or national activities
 - Advocates for patients and the community
 - Participates in scholarly activities related to the practice of medicine
 - Demonstrates professional, respectful and ethical behavior

Award Logistics

Graduate notified by email, official letter and award provided at Fall Convocation event

3. PA Student Clinical Excellence

Description

➤ To recognize a Year 2 PA student for demonstrating clinical excellence in his/her clinical rotations

Eligibility

- > Any Year 2 BScPA Student in good standing
- Winners of another PA student Award, are not eligible for this award

Nomination

- Nominated by preceptors
- Nomination is to include:
 - Full name of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:
 - o A summary of the known contributions supporting the nomination
 - o Examples of the student demonstrating clinical excellence

Selection Criteria

- > Judged by the Awards committee
- Excellent example of all CanMEDS-PA roles as demonstrated in the clinical environment

4. PA Student Leadership Award

Description

To recognize a Year 2 student who has demonstrated strong leadership skills throughout the BScPA Program

Eligibility

- Any Year 2 BScPA Student in good standing
- Winners of another PA student Award, are not eligible for this award

Nomination

- Nominated by peers, and/or faculty
- Nomination is to include:
 - Full name of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:
 - A summary of the known contributions supporting the nomination
 - Examples of the student demonstrating leadership excellence

Selection Criteria

- Judged by the Awards committee
- Criteria to include:
 - Excellent leadership skills during the program

5. PA Student Scholarly Excellence Award

Description

To recognize a Year 2 student who has shown excellence in their Year 2 Quality Improvement (QI) project

Eligibility

- Any Year 2 student who has completed a Quality Improvement Project
- Winners of another PA student Award, are not eligible for this award

Nomination

- ➤ PAP265 Evidence Based Medicine (EBM) Course director nominates top 3 QI projects Nomination is to include:
 - Full name, title of QI project
 - The abstract of the QI project proposal

Selection Criteria

- Judged by the Awards committee
- Criteria to include:
 - Scholarly work that contributes to Quality Improvement with the potential positive impact on patient care/ health care system

6. PA Ethical Decision-Making Award

Description

To recognize a Year 2 student who has shown excellence in their Year Ethical Decision-Making Final paper

Eligibility

- Any Year 2 student who has completed the PAP269 Ethics course
- Winners of another PA student Award, are not eligible for this award

Nomination

- PAP269 Ethics Course director selects best 3 papers which exemplifies the use of a model of ethical decision making in a clinical case. These are submitted to the Awards Committee

Selection Criteria

Judged by the Awards committee as to the final award recipient

- Criteria to include:
 - Scholarly work that incorporates ethical decision making in a clinical case.

Faculty Awards

7. PA Excellence in Teaching Award

Description

> To recognize outstanding teaching in the BScPA Program

Eligibility

- A teacher in the BScPA Program; may be a course director, TA, guest facilitator, guest speaker, or preceptor
- > Individuals who won this award in the previous 3 years are ineligible
- Nominees are not required to have DFCM faculty appointment
- > Nominees may be from any clinical discipline or have an equivalent designation of expertise

Nomination

- Nominated by students
- Nomination is to include:
 - Full name, title, and professional designation of the nominee
 - Name of the nominator
 - Up to 1000 character statement describing:
 - o A summary of the known contributions supporting the nomination
 - o The impact of these contributions on students

Selection Criteria

- Judged by the Awards committee
- Criteria to include any of:
 - Contributes to student learning as a role model for others
 - Commitment to quality teaching:
 - Accessibility to supporting student achievement
 - Innovative teaching methods
 - o Excellent organizational skills
 - o Stimulates critical thinking in students
 - o Demonstrates enthusiasm for subject matter

Award Logistics

Winner is notified by email, official letter and award provided at Fall Convocation events

8. PA Role Model Award

Description

> To recognize an outstanding Physician Assistant involved in the BScPA Program

Eligibility

- ➤ A Physician Assistant involved in the BScPA Program; may be related to teaching, mentoring, collaborating, or supporting (includes course directors, TAs, guest facilitators, guest speakers, and preceptors)
- Individuals who won this award in the previous 3 years are ineligible
- Nominees are not required to have DFCM faculty appointment
- Nominees must be a Canadian Certified Physician Assistant

Nomination

- Nominated by students, peers, self, faculty or PA teachers
- Nomination is to include:
 - Full name, title, and professional designation of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:
 - A summary of the known contributions supporting the nomination
 - o The impact of these contributions on students

Selection Criteria

- Judged by the Awards committee
- Criteria to include any of:
 - Demonstrates the key roles that define a Physician Assistant, as a:
 - Medical Expert
 - Communicator
 - Collaborator
 - o Leader
 - Health Advocate
 - Scholar
 - o Professional

9. Faculty Scholar Award

Description

➤ To recognize a BScPA Faculty member, teacher/facilitator or teaching assistant who has demonstrated excellent scholarly work

Eligibility

➤ BScPA faculty member, teacher/facilitator or teaching assistant who has published or presented scholarly work at the local, provincial, national or international level

Nomination

- Nominated by students, peers, self, faculty or PA/MD teachers
- Nomination is to include:
 - Full name, title, and professional designation of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:

- A summary of the scholarly work
- o Why this is a demonstration of excellent scholarly work
- Link to the work (if available)

Selection Criteria

- Judged by the Awards committee
- Criteria to include:
 - o Impact on PA education or health care system

10.PA Preceptor Excellence Award

Description

To recognize an MD or PA preceptor for the BScPA program who has shown excellence in the clinical environment

Eligibility

> Any MD or PA preceptor who works with a BScPA learner in the clinical environment

Nomination

- Nominated by students at the end of their evaluation forms
- Nomination is to include:
 - Full name, title, and professional designation of the nominee
 - Name of the nominator
 - Up to 1000 character statement describing:
 - A summary of the known contributions supporting the nomination
 - o Examples of the preceptor demonstrating clinical excellence

Selection Criteria

- > Judged by the Awards committee
- Criteria to include:
 - Demonstration of excellence in all <u>CANMEDS</u>/ <u>CANMEDS-PA</u> roles

Alumni Award

11. PA Rising Star Award

Description

To recognize an alumna/alumnus of the BScPA Program for their outstanding contributions to the PA Profession

Eligibility

- > A graduate of the BScPA Program
- Individuals who won this award in the previous 10 years are ineligible

Nomination

- Nominated by peers, self, faculty or PA/MD teachers
- Nomination is to include:
 - Full name, title, and professional designation of the nominee
 - Name, title and professional designation of the nominator and relationship to nominee
 - Up to 1000 character statement describing:
 - o A summary of the known contributions supporting the nomination
 - o The impact of these contributions on students

Selection Criteria

- > Judged by the Awards committee
- Criteria to include any of:
 - Collaborates with others
 - Provides service to advance the PA profession
 - Demonstrated leadership in local, regional or national activities
 - Advocates for patients and the community
 - Participates in scholarly activities related to the practice of medicine
 - Demonstrates professional, respectful and ethical behavior
